<p><b>Timeframe</b></p>	<p>Applications can only be made online through our website. The application period is open for three months and the NRAIT Board considers this sufficient time to submit an application; therefore requests for an extension will be declined.</p> <p><b>2017 dates:</b> Applications open 1 June 2017 and close 31 August 2017; Decisions advised by 30 September 2017.</p>
